5. Debarring from representing the institution in any conference, seminar and cultural program.

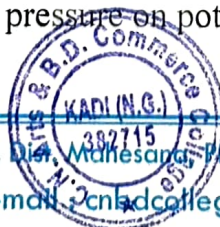
